How do I nominate?

Nominations are made by completing the form below and lodging it as directed by the due date.

Conditions of a valid nomination

1. The nomination form is signed by two financial voting members of the AES; and
2. The Acceptance of Nomination is signed by the nominated member; and
3. The nominee either possesses or will immediately apply for a Director Identification Number
4. A brief nominee statement is provided, including declaring interest in other organisations (see below); and
5. Completed form and statement are lodged to the Returning Officer no later than 4:00pm AEST Friday 15 August 2025.

NOMINEE STATEMENT: Nominees must supply a brief statement to the Returning Officer addressing the skills they will bring to the board to assist achieving the vision, aims, and strategy of the AES, and reasons for nominating (no more than 350 words), along with declaring interests in other organisations (voluntary or paid).
