# The landscape



- Advocacy evaluation models which service traditionally disenfranchised (Mertens and Hopson 2006).
- Values engaged evaluation (Greene, DeStefano, Burgin, & Hall, 2005)
- Participatory
  - Transformative participatory evaluation (Cousins and Whitmore 1998).



# Umbrella terms..

- Collaborative, participatory, empowerment all used interchangeably
- Collaborative evaluation
  - ...Any evaluation in which there is a significant degree of collaboration or cooperation between evaluators and stakeholders in planning and/or conducting the evaluation. (Cousins, et al, 1996)



# Umbrella terms

- Partnership approach to evaluation which stakeholders actively engaged in developing the evaluation and all phase of implementation
- ...is about sharing knowledge and building the evaluation of stakeholders - community, implementers, funders and others
- Stakeholders determine the evaluation focus, design and measures within an appropriate social, cultural and economic context (Zuoski,2002)

- Giving voice...

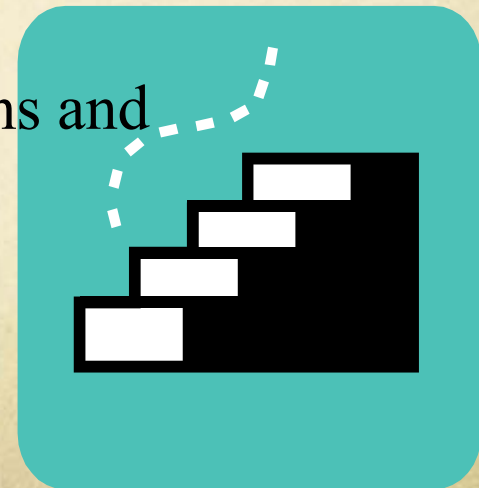
# The benefits are...

- Builds knowledge and skills among stakeholders
- Builds relationships between stakeholders
- Utilises local knowledge – in implementation
- Utilises local knowledge – analysis and interpretation  
‘sense making’
- Inclusion, giving voice....

# Provide a process, some steps and guidelines for practice

Typically include process for engagement:

- Identifying relevant questions
- Planning the evaluation design
- Selecting appropriate methods/measures
- Gathering and analysing data
- Reaching consensus about findings, conclusions and recommendations
- Disseminating results
