### WHAT IS ADVOCACY?

Activities by individuals or groups which aim to **influence** decisions within political, economic, and social systems and institutions, usually to advance the public good.

Advocacy is most effective when there are recognised and sustainable avenues to build and maintain relationships, foster communication about issues and developments, and collaboration on solving problems.

EFFECTIVE RELATIONSHIPS GIVE RISE TO NEW WAYS OF ANTICIPATING AND RESOLVING NEEDS



## ADVOCACY: WHERE HAVE WE COME FROM?

Initial focus on community of evaluation professionals as well as others who are somehow involved in evaluation
